The Centrale Pharmaceutique d'Achats du TCHAD (in abbreviation: "CPA") is launching an International Open Tender for the Pre-selection of Suppliers and Product/Manufacturer/Production Site Pairs.

The aim of this procedure is to draw up a list of approved suppliers for their product/manufacturer combinations, after assessing the skills of suppliers, manufacturers and product quality.

Accreditation will be valid for a period of 4 years, and will enable pre-selected suppliers to participate in restricted consultations or invitations to tender during this period.

The Prequalification will cover the following list of Supplies:

- Essential generic medicines, under International Non-proprietary Name (INN) :
 - Oral medicines
 - Injectable medicines
 - Infusion solutions
 - External medicines
- Medical Consumables
- Medical and technical equipment
- Laboratory reagents and equipment
- X-ray films and diagnostic products

The present International Open Tender for Prequalification is open on equal terms to all legal entities or individuals, without restriction of nationality, authorized to manufacture, distribute, import or export the products listed above, intended for use in human medicine, and complying with the pharmaceutical legislation in force in CHAD and in the country where they are established.

Bidders proposing products not manufactured by themselves shall produce a license or distribution authorization issued by the manufacturer of each item proposed.

The amount payable is determined by the number of health products offered, as follows:

- 250,000 FCFA between 1 and 5 products offered
- 350,000 FCFA between 6 and 30 products on offer
- FCFA 500,000 for a number of products greater than or equal to 31 products on offer

The sum to be paid shall be made either by certified cheque payable to CPA, or in cash deposited with CPA, against receipt, or, for suppliers established abroad and not represented in the Republic of CHAD, by international bank transfer made payable to CPA (Bank references below).
